### SHELF LIFE

This product has a shelf life of 24 months from the date of manufacture when stored unopened at room temperature. For shelf life after opening: see indication on packaging.

### SUITABLE FOR USE IN FOOD HANDLING

The use of Refresh™ Clear FOAM as per usage instructions, does not influence the quality and safety of foodstuffs.

The product has been assessed using the HACCP hazard analysis methodology. The following critical control points were identified and are controlled as follows -

1. Impact on smell and taste of foodstuffs - The formulation has been independently tested according to 'Sensory Analysis - Methodology - Triangle Test BS EN ISO 4120:2007' and proven to not have the potential to taint food.
2. Possible toxic effects of ingredients - An independent oral toxicological evaluation was performed and concluded that any foodstuffs which may contain trace amounts of the product, are unlikely to cause any adverse toxicological effects.
