DESCRIPTION

FRESHMINT LV is a neutral liquid detergent with a pleasant mint perfume. It can be used for manual dishwashing, general cleaning, vehicle washing and light degreasing. It is safe to use, non-toxic and contains no solvents. Its mild formula will not damage the surface allowing for effective cleaning and is gentle to skin.

DIRECTIONS FOR USE

Dishwashing: Use at 1-2 mL/L of hot water depending upon the degree of soiling. **General Cleaning and Degreasing**: Use at 10-30 mL/L of cold or hot water.

Apply with a cloth, sponge or a mop. Remove excess of water from the surface and allow to dry. No rinsing is required. For vehicles detergent residues should be hosed off to prevent streaking. Gentle on the hands but prolonged immersion in solution should always be avoided. Rubber gloves to be worn where possible.
